Programs at the Murrieta Student Center will provide a teacher for the student and provide assignments for both homeschool days and class days. The teacher will provide on site day work, assign homeschool day work, post assignments on CANVAS, and give grades for coursework completed at end of each semester.

- I will oversee homeschool instructional days as assigned by teachers.
- I will turn in all homeschool assignments corrected and reviewed incorrect answers with my child.
- I will attend the beginning of the year program orientation or make every effort to receive all information that I have missed.
- I will demonstrate support of the program mission, student handbook expectations, curriculum and instruction.
- I will ensure that my student attends Academy Days.
- I will make sure my child complete all homework assigned/monthly projects and works to the best of his/her ability.
- I understand that RSCS will place my child on insufficient progress status should they fail to meet academic expectations (which is defined as 70% of work assigned—to the best of the student's ability) my student may be placed in the **Inadequate Progress Process**, which will determine if my student may continue at their current academy.
- I will attend Parent Conferences as scheduled by the teacher and I.
- I will check Canvas, Illuminate, and my email at least once per week in order to ensure that my student is prepared to fully participate during academy days.

- I will contact the teacher for help if my child is struggling to master skills.
- I will ensure that my child participates in all applicable state and school required tests. (This include PE Testing (5th & 7th Grade) and CAASPP - California State Testing)
- I will replace all materials lost or damaged by my student.
- Classical Homeschool and Casa Montessori school hours are 9:00am-3:00pm. I will ensure that my student is dropped off and picked up in a timely matter. (Drop-off NO EARLIER than 8:45am and NO LATER than 9:05am; Pick-up NO LATER than 3:15pm.)
- Da Vinci and Montessori Middle School hours are 8:45am-2:45pm. (Drop-off NO EARLIER than 8:30am and NO LATER than 8:50am; Pick-up NO LATER than 3:00pm)
- *I understand that students at River Springs Charter School are expected to achieve one year of academic growth during the school year. I also understand that the first year of Independent Study with RSCS is a trial year. It may be determined that my student is not a good candidate for Independent Study, and an alternate program may be recommended.*
